Benefit/Outcome: Improve Mental Health

Students are provided social and emotional educational program, and taught skills to manage their stress emotions. Students have mentors they can confide in. There is also the "Bloom Tea Room" which is a relaxing room, where students are welcome to go in the room to calm down and relax when they're overwhelmed emotionally. The room has a sign in sheet documenting the attendance. Mentors also provide check ins with the students. Benefit/Outcome: Enrich Cultural Experience This is done through field trips to museums, Universities. Student attendance to the field trips is documented.

Benefit/Outcome: Improve Education

To increase the academic performance girls are provided individualized mentorship, resulting in an improvement in grades, school attendance, and engagement in their learning. This is documented by using high school graduation rates, GPAs, surveys, progress monitoring for the girls and how many admitted to college and or a tech school
