Improvements to the Cuban Club Building interior will keep the building commercially viable as a performing arts, event and convention center. Improvements include - Repair, remodel and update four large restrooms. Return the 2nd floor and basement entrances to their original design. Replace four HVAC units that have reached the end of their life expectancy. Purchase replicas of the historic tile for basement and 2nd floor and install. Update electrical service in basement and 2nd floor. Conduct an engineering study of the building. Architectural services.

#### b. What activities and services will be provided to meet the intended purpose of these funds?



The Foundation will hire an architect, engineer and contractor to make the improvements and repairs that are within the scope of the project. All work will be permitted, approved by the Barrio Latino Commission and when complete, inspected.

#### c. What direct services will be provided to citizens by the appropriation project?

The repair of the Cuban Club will ensure its activity as a venue for a variety of events such as concerts, performances, art and commercial exhibits, political rallies and gatherings, non-profit fund raisers, weddings and other events along with attracting a wide spectrum of tourist visitors. As a major contributing structure to the Ybor City National Historic District the Cuban Club helps drive the overall tourism to the district. The repairs to the building will also create immediate construction jobs. Also the County requests our building as a hurricane shelter and distribution center.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

While the construction project doesn't serve individuals or a target population the building is visited and used by close to 60,000 people a year.

#### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

The repairs will encourage and promote more use of the building as a convention/events center, a tourist attraction, a concert facility and as a storm shelter and distribution center during hurricanes. Our success will be measured by an increase in events, attendance and rented room nights. Increased use will also cause an increase in remitted sales taxes and a jump in parking fees at neighboring City of Tampa Parking Garages and street parking.
