### 4. Project/Program Description

This project is for architectural design, engineering and permitting services to build a 18,000 square foot fire rescue, EMS, police and Public Works Headquarters on Town of Cross City (Town) owned property located at the northwest corner of NE 210th Avenue and NE 118th Street. The new building complex is immediately adjacent to City Hall and will accommodate police services, emergency services, fire rescue, public works headquarters (dispensed currently from City Hall) and have the capability to be used as an emergency operations center as needed. The facility will position each entity to meet current minimum standards for public safety buildings and to deliver new and improved public services that were not previously possible for an increasing population.

### 13. Program Performance

## a. What specific purpose or goal will be achieved by the funds requested?

The requested funds would allow for the architectural and engineering design of the building including the preconstruction management services. The Town of Cross City's current public works facility and chief of police office (including evidence room) is housed currently within City Hall. Due to the limitations of the facility and incoming growth, a new building is required. This building complex will accommodate the Police Department, the Town's Public Safety Facility, Fire Services, and Public Works Headquarters at one central location and will provide security, safety, emergency response, and police presence.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

The Town will execute a contract for planning, engineering and permitting services to move forward with the construction of the proposed facility.

#### c. What direct services will be provided to citizens by the appropriation project?

Direct services to citizens includes improved fire services, police services, improved life, health, safety, and protection of property due to quicker emergency response times for fire rescue and police services.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The new public safety facility will service Cross City's 1,800 residents and seasonal visitors and would be available as an additional resource to bordering cities and Dixie County support that serve an approximate combined 18,000 residents. The fire and police departments have mutual aid agreements to provide assistance to neighboring cities in times of crisis and emergency.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The new facility will provide a place for training, community outreach, policing, public safety during natural disasters. It will provide improved response times for fire rescue, police and public works support. The benefit is the increased safety of citizens, visitors and the business community. The outcome will be measured by collecting data on response times, impact of training activities and number of residents served. In addition, the facility will include basic industry standards to protect the health of our emergency responders and also to extend the conditional and life span of critical fire apparatus and support equipment. Additionally, the police will have the appropriate space to safely receive, interview and secure persons of interest as well as secure evidence per designated requirements.

### f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties

#### for failing to meet deliverables or performance measures provided for in the contract?

The contracting agency will establish a Critical Path with specific dates for design and designated deliverables. Once bids are

received and awarded for the project, the contract will have specific contract completion dates; if not met, the selected firm

will be subject to Liquidated Damages, assessed on a daily basis. Failure to meet deliverables or performance measures will result in reduction or total loss of funding.
