13. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The specific purpose is to serve the 30 network museums/sites that will receive direct grants from the FAAHPN network to help support their historical and cultural programming, technology upgrades, internship programs, heritage tourism, and serve the general public. These funds allow FAAHPN to be a resource for institutions, individuals, and agencies where the intellectual property, oral histories, and artifacts/or cultural treasures are needed to carry out major themes or programs.

b. What activities and services will be provided to meet the intended purpose of these funds?

Activities and Services to be provided to Network Executive Directors and staff include: technology and equipment acquisitions, content development and research, exhibit development/installation, preservation of documents and artifacts, internships, two sessions for professional development, marketing, traveling exhibits.

c. What direct services will be provided to citizens by the appropriation project?

Direct services to citizens include: Tourism ready venues to visit and appreciate the history of communities across Florida and to learn of those who contributed to the development of that history. The FAAHPN serve as a repository for material culture, artifacts and collections, that might otherwise be lost. Educational program assistance and provision of assistance to community partners in the planning and implementation of heritage events benefit is a frequent and direct benefit. Moreover, FAAHPN museums are centers for the public to visit to conduct research and enhance skills in historic preservation.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target populations served are the elderly, economically disadvantaged persons, at risk youth, physically disabled, preschool students, grade school students, high school students, university college students, "history buffs" and anyone seeking and needing historical information and services.

More than 400K people are expected to be served physically/onsite and an additional virtual audience included in FAAHPN social media platforms.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

The outcome of this project is as follow:

1. To sustain history and cultural tourism venues and opportunities for the public to know about and explore the State of Florida

2. To increase economic activity and add new revenue coming into the state resulting from tourist engagement and promotion, the sale of FAAHPN publications and documentaries and attraction of new partners for the State as a result of the very successful Florida Network of museums.

3. To safeguard our landmarks, legacies and collections and to inform and educate the public of our purposes,

accomplishments and contributions to the State of Florida.

The methodology by which this outcome will be measured is our annual Economic Impact Report based on raw data from FAAHPN museum and extrapolated by FSU Center for Economic Forecasting & Analysis (CEFA), and our Federal Survey Institute of Museum and Libraries Report.


The report documents a clear benefit to the state's revenue and service to the communities.
