At Glory House, we provide long-term restoration to survivors of human trafficking -- one heart at a time. Through our Independent Living Program, our team provides wraparound support and specialized care coordination for survivors who are currently living on their own and seeking a life of freedom. In 2025, we are opening our residential home to provide the safety, stability, and support survivors need to get to the root of their healing and re-enter society as whole individuals who have broken the cycle of exploitation and trauma. This will be the first long-term residential home for adult female survivors in South Florida.

The funding will allow Glory House to roll out operations and staffing for our safe home and independent living program by providing high-caliber staff to mentor, advocate, and serve survivors so that they can achieve true healing and autonomy. Our program greatly reduces the outcome of survivors returning to the cycle of exploitation, depending on government assistance, and breaks inter-generational sexual exploitation in their children.

b. What activities and services will be provided to meet the intended purpose of these funds?

Our Residential Program provides survivors a minimum of twelve (12) months to live in the safe home to heal from their trauma and re-enter society as a thriving individual. Our Independent Living Program provides survivors with over thirtyfive (35) wraparound services, and our goal in both programs is to help survivors reach true autonomy, health, and stability.

c. What direct services will be provided to citizens by the appropriation project?

Glory House will be providing direct care and wraparound support to adult female survivors in our Independent and Residential Living Programs. We provide over thirty-five (35) wraparound support services and supply targeted in-house care coordination, partnership referrals, financial literacy, trauma therapy, job readiness, and strategic goal setting along with measured accountability and milestones that are met, so each survivor can heal and reach the autonomy and selfsufficiency to flourish as they re-enter society as a restored person.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population is adult female survivors of sex trafficking. A minimum of (25) survivors in our Independent Living Program and a minimum (4-6) survivors in our Residential (for 12 months) will be served through our holistic, lifechanging model of support.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

At Glory House, we track a multitude of metrics for each survivor demonstrating how we provide direct financial assistance (rent, groceries, personal aid, etc.) through our program along with wraparound support. This includes strategic short and long-term goal setting, job readiness, health, financial literacy, and other metrics showing the transformation that happens for a human trafficking survivor when long-term support and restoration is the goal.
