Operating funds will be used to purchase vehicles to transport individuals to employment opportunities, as well as provide transport of commodities, and purchase equipment necessary to expand work opportunities for individuals with disabilities. Fixed capital funds will be used to improve the facilities ability to expand work production and house equipment needed for the business.

c. What direct services will be provided to citizens by the appropriation project?

Transportation services will be expanded and provided to individuals to be able to get to and from work. Job opportunities will be provided to individuals that we serve and expand our ability to employ more people.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population served by this project are persons with poor mental health, elderly persons, jobless persons, economically disadvantaged persons, and developmentally disabled persons.

The expected outcomes include improved mental health services and expansion, transportation, increased economic activity, creating immediate job opportunities, and enhancing individual's self-sufficiency. Measurements include self-report and assessments, staff observations, quantifiable data from increased numbers in various categories, supplemental information and training, and co-occurring services through the program.


