A new ladder truck is needed and is essential to ensure County coverage of large commercial structures and multi-story residential buildings in emergency situations and to efficiently serve citizens and the community in this Rural Area of Opportunity (RAO) to protect life, health and properties. The current aerial truck was purchased used and is currently 28 years old, which is well past its useful lifespan.
