#### 4. Project/Program Description

The Florida High School High Tech (HSHT) program, administered by The Able Trust, is a transformative initiative that prepares youth with disabilities for meaningful careers, especially in Florida's high-demand industries. To meet the growing need for services and expand the program's reach from 1,200 to 5,000 students statewide over the next four years, increased legislative funding is required. Specifically, additional funding for staff, travel, and technical assistance will enable The Able Trust to effectively coordinate and support this expansion, ensuring that the program's impact reaches every corner of the state.

#### a. What specific purpose or goal will be achieved by the funds requested?

An investment in program staffing, travel, and technical assistance is critical to statewide expansion and long-term success. By providing the resources needed to scale operations from 1200 to 5000 students served annually, The Able Trust can increase access to life-changing opportunities for youth with disabilities, empowering them to succeed in education and employment while driving Florida's economic growth. Increased legislative funding will ensure that the HSHT program continues to be a leader in preparing the next generation of skilled workers attuned to the needs of Florida's businesses.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Recruiting additional staff to manage site operations, provide technical assistance, and ensure program compliance. Travel to prospective and existing sites to build local capacity and provide hands-on support to local program coordinators. Funding of professional development, program materials, and technologies that will enhance learning experiences for students.

#### c. What direct services will be provided to citizens by the appropriation project?

Students with disabilities will participate in industry tours and presentations; connections to career supports including Vocational Rehabilitation services; Career and Technical Education, apprenticeships, and other post-secondary education programs; soft skills training; and leadership development. Parents will receive guidance on post-secondary resources and supports to avoid the "service cliff" after high school graduation.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

High school students with disabilities who have an Individualized Education Plan (IEP) or 504 plan. 1800 students, which includes an addition of 600 students, will served by this project.
