Education is the Bridge to Health Literacy equips multi-disciplined college students and low-income individuals with crucial knowledge about breast cancer and heart disease prevention and early detection to fight leading causes of largely preventable deaths in Florida. This comprehensive program will empower 1,200 individuals by merging health education and direct community engagement, ensuring a broader understanding and adoption of living disease deterrent lifestyles which has proven to reduce healthcare costs and save lives.

#### 13. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

Requested funds will expand health education to improve health literacy with a focus on breast cancer and heart disease, two of the most costly and leading causes of largely preventable deaths in Florida. These funds will empower targeted populations to live disease deterrent lifestyles which have been proven to save lives, reduce costs, and improve public health outcomes.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

To meet the intended purpose of the requested funding, digital curriculum delivery will be provided to college students about breast cancer, heart disease, disease prevention, early detection, clinical trials, and the SDOH, along with student peer group advocacy to broaden the impact. Additionally, low-income individuals are targeted to receive health education through community outreach engagement and health educational materials.

#### c. What direct services will be provided to citizens by the appropriation project?

This appropriation project will directly:1) Provide education about breast cancer, heart disease, disease prevention, early detection, clinical trials, and SDOH virtual education to citizens attending post-secondary academic institutions. 2)Provide low-income citizens with critical health education about breast cancer, heart disease, disease prevention, and early detection through their participation in health educational rallies and the receipt of health educational materials which include sites providing low-cost preventive screenings.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

Education is the Bridge to Health Literacy will educate 900 multi-disciplined college students including future healthcare professionals about breast cancer, heart disease, disease prevention, early detection, clinical trials, and SDOH; and 300 low-income individuals will receive health education about breast cancer, heart disease, disease prevention, early detection, and clinical trials. In total 1,200 individuals will be served through virtual health education & direct community engagement.

### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

The expected benefit of the project is increased health literacy about breast cancer and heart disease among college students and economically disadvantaged individuals. Success will be measured by 1) 900 college students completing the virtual program with assessments documenting increased knowledge; and advocacy documented by 3,000 social media impressions and at least 9,000 engagements 2) 300 individuals experience increased knowledge as documented at health educational rallies and by surveys conducted with individuals receiving health educational packages.
