13. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The funds will be allocated to create two facilities in Palatka—one accommodating 60 women and children, and the other for 40 men. Also one 10-unit apartment building for permanent residence. These centers will offer shelter along with crucial support services, including mental health and substance abuse counseling, as well as housing identification and placement. Given the increasing rates of homelessness, this initiative seeks to provide stability, essential resources, and a clear pathway toward self-sufficiency for those in need.

b. What activities and services will be provided to meet the intended purpose of these funds?

The facilities provides shelter, food, and basic necessities for homeless persons. Wraparound services include, mental health and substance abuse counseling, housing identification and placement support, SOAR linkage, and outreach services. Additional services will cover healthcare access, life skills training, educational programs, transportation assistance, and case management.

c. What direct services will be provided to citizens by the appropriation project?

Using agencies who have established homeless services programs, the City will partner with them to leverage existing programs with increased funding. Rapid re-housing services, for instance, would include housing identification, rent and move-in assistance, and rapid re-housing case management and services.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population is elderly persons, persons with poor mental and physical health, veterans, jobless persons, economically disadvantaged persons, at-risk homeless youth, physically disabled and formerly incarcerated persons. We expect to serve between 200 to 300 individuals, which will include the students in grades K to 12th.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

The project aims to reduce homelessness by offering shelter and supportive services, including mental health counseling, substance abuse treatment, and housing assistance. Through intensive case management, it promotes self-sufficiency. Success will be measured using the Homeless Management Information System with metrics such as initiative participation, and average stay.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

Our intent would be to complete the project with meeting the deliverables and performance measures. If there is a performance deficiency requiring correction by the City, the Agency will notify the City. The City will provide the Agency with a corrective action plan describing how the City will address performance.
