#### 13. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?



Washington County (County) is seeking appropriations funding for the construction of a new fire station to enhance public safety and improve the county's Insurance Services Office (ISO) ratings. This new facility will reduce emergency response times, increase firefighting capabilities, and ensure more efficient service for residents and businesses. Improved ISO ratings can lead to lower insurance premiums for property owners, reflecting the strengthened fire protection measures in place. Additionally, the fire station will provide essential resources and training opportunities for Washington county fire fighters, further improving the county's emergency preparedness. This investment in public safety infrastructure is critical to protecting residents and fostering a more resilient community, and we respectfully request funding support to make this project a reality.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

As Sunny Hills continues to grow, this facility will ensure safety to that community. The requested structure would provide fire protection services and ems services to the Sunny Hills area and the surrounding regions of the County. The fire station would also provide support in the aftermath of disasters and accidents along the SR 77 corridor. Washington County is a fiscally constrained county that doesn't otherwise have the funds to address this major need.

#### c. What direct services will be provided to citizens by the appropriation project?

A new fire station would provide significant benefits to the citizens of Washington County, particularly as a fiscally restrained county facing challenges in maintaining and improving public safety services. By strategically enhancing emergency response capabilities, the fire station would reduce response times, improve fire suppression efforts, and ensure better coordination among first responders. This would lead to improved Insurance Services Office (ISO) ratings, which can lower property insurance costs for homeowners and businesses providing direct financial relief to residents. Additionally, a modern fire station would optimize resource allocation, improve training for emergency personnel, and enhance disaster preparedness, ensuring that Washington County maximizes efficiency while working within budgetary constraints. Investing in this infrastructure through appropriations funding would allow the county to improve public safety.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The construction of a new fire station in Washington County would directly benefit its approximately 35,000 residents by enhancing emergency response capabilities across the entire community. With improved infrastructure, first responders would be better equipped to handle fires, medical emergencies, and natural disasters more efficiently, reducing response times and increasing overall public safety. The fire station would ensure that fire and emergency personnel have the necessary resources to provide high-quality services county-wide. Additionally, by improving the county's Insurance Services Office (ISO) ratings, property owners throughout Washington County could see reduced insurance costs, creating financial benefits for homeowners and businesses alike. As a fiscally restrained county, this investment would ensure that all residents receive improved emergency services while maximizing efficiency.

The construction of a new fire station in Washington County will enhance public safety by improving emergency response times, increasing firefighting capabilities, and providing modern training resources for first responders.
