Still Waters is committed to supporting homeless families by providing free transitional housing in a safe and secure environment at the CHROME Retreat, a 30-acre property in Marianna, Florida. Homeless families often face ongoing abuse and victimization, and this initiative aims to provide stability, safety, and access to essential resources for recovery. The project involves constructing eight two-bedroom cottages to serve as transitional housing. Funding will cover architectural and engineering services for mechanical, plumbing, and electrical systems, as well as the design, transport, and construction of the cottages' foundations. Additional resources will support utility connections, including city water, electrical power lines, and gas services, along with paving a road for accessibility. Necessary permits and inspections will also be secured to ensure regulatory compliance. This initiative will provide a safe and stable living environment, helping families rebuild their lives.

a. What specific purpose or goal will be achieved by the funds requested?

A program of CHROME Ministry. Focused on breaking the cycle of abuse.

b. What activities and services will be provided to meet the intended purpose of these funds?

We are coordinating efforts to transport, renovate, and furnish eight cottages on the CHROME Retreat property. This initiative involves engaging Donofro Architects and Watford Engineering to provide comprehensive professional design services, including Mechanical, Plumbing, and Electrical Engineering. Additionally, we are partnering with Baxter's Asphalt Inc. in Marianna to discuss paving services for a road on the property. Coordination with the city will also be necessary to establish water and gas utilities, while Florida Public Utilities will be engaged to connect power lines to the cottages.

c. What direct services will be provided to citizens by the appropriation project?

Through transitional housing, counseling, mentorship, and essential life skills training

d. Who is the target population served by this project? How many individuals are expected to be served?

This includes struggling homeless families, women and children.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Our addiction recovery program empowers mothers to heal from past trauma, overcome addiction, and improve their physical and emotional well-being through a holistic approach that integrates mind, body, and soul.

We provide safe, free transitional housing and essential services, including USDA-approved meals, counseling, Bible studies, and vocational training. Mothers and children receive comprehensive support, including school enrollment with necessary supplies and internet access, fostering stability and growth.

Our janitorial vocational training equips participants with practical skills, enhancing job opportunities and financial independence. At-risk youth also benefit from counseling, tutoring, and conflict resolution training to build healthy, non-violent relationships.

Led by staff who have triumphed over similar challenges, the program emphasizes mutual support and role modeling, creating an environment of hope and resilience.

In the event that the construction of the 8 transitional houses for women and children is not completed or the promised deliverables are not met, we will return 100%.
