13. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The funds requested are for the acquisition and retrofitting of a deployable mobile command post (CP)/Emergency Operations Center (EOC) which will be utilized throughout the City of Doral and/or deployed to any of the satellite cities that fall under the Doral Divisional EOC. The mobile CP will contain the necessary equipment to deploy effectively and provide operational and logistical support during a significant critical incident, security event, man-made or natural disaster (i.e., hurricane) or industrial incident.

b. What activities and services will be provided to meet the intended purpose of these funds?



In the event of a major disaster situation or critical incident, it is necessary for first responders and supervisors to deploy in order to provide an effective law enforcement response and/or relief operation. At times, especially in South Florida, when responding during post hurricane devastation, it is necessary to provide continuous 24-hour resources and assistance in various locations. This project will allow the DPD to provide a more effective response saving time and valuable resources.

c. What direct services will be provided to citizens by the appropriation project?

A mobile CP will provide the community with enhanced response capabilities which include rapid deployment, on-scene central command, advanced response/technology, neighborhood outreach, special event/support, and disaster response in a mobile workspace to better respond during emergency situation and emergencies.

d. Who is the target population served by this project? How many individuals are expected to be served?

The mobile Command Post will provide enhanced public safety for the community we serve and the satellite cities who report to the City of Doral Divisional EOC. Within the City of Doral, the proposed project will support enhanced emergency police response for approximately 200,000 individuals, including residents, visitors, business owners, and employees, ensuring a safer and more secure environment for all.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

This project will allow for the Doral Police Department to be prepared to provide extended emergency response throughout the City of Doral, ensuring that all personnel have access to equipment and resources during a major incident. The Doral Police Department will be able to reinforce our emergency response services to better help the citizens of the City of Doral and beyond. The benefit of a mobile Command Post can be measured by conducting a Benefit Assessment to include Log of deployment/incident engagement, collection of data during events (community engagement, public satisfaction surveys, social media analytics), review the feedback and data collected, evaluate the findings and complete a report with findings and recommendations during the specified time.
