The project entails the modification of 35 traffic signal controller cabinets to mitigate flood impacts and saltwater intrusion during storms, particularly in low-lying coastal areas affected by Hurricanes Helene and Milton. Protection options include elevating the cabinets on platforms or mounting them to poles which will enable a quicker recovery of traffic control systems critical to public safety.
