#### 4. Project/Program Description

Teach For America (TFA) Florida began in 2003 in Miami-Dade. We are working for Florida to decrease teaching vacancies and continue to provide novice teacher training to TFA and traditional teachers. Our goal is to enlist at least 250 new leaders and support the current 2,500 members of our Florida network working in K-12 schools. Florida began this year with over 4,000 vacancies. Our goal is to recruit and retain quality educators at scale within our budget to help decrease the shortage in our region: Miami-Dade, Tampa, Orlando, Jacksonville and expand to rural areas.

#### 13. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

Expanding recruitment pipelines- TFA will partner with Florida's ongoing efforts to reduce vacancies by recruiting and placing teachers in Miami-Dade, Jacksonville, Tampa and expand to rural areas like Polk, Pasco, and Jefferson counties. Expanding teacher training-TFA will annually train over 4,000 educators, including new teachers from alternative pathways, such as military veterans, who would benefit from professional development.



#### b. What activities and services will be provided to meet the intended purpose of these funds?

TFA Florida is committed to our mission to find, develop, and support talented leaders individually and in teams so they can transform education and expand opportunities for children, starting in the classroom. TFA has sourced teachers in Florida for over 20 years, and this funding supports us in growing and strengthening that workforce pipeline by decreasing teaching vacancies.

#### c. What direct services will be provided to citizens by the appropriation project?

Teacher recruitment- recruiting and training certified teachers to decrease vacancies. Teacher preparation program-professional development to TFA and non TFA educators. Impact reaches students, families and school communities in Florida.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The target population served by this project is K-12 students, jobless persons looking for work with bachelor's credentials and teacher certifications, at-risk youth, and recruitment of college/working aged students to join the education profession.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

A decrease in Florida's teaching vacancies and how many TFA recruits we contribute will determine our outcome. Additionally, the number of teachers we train including non TFA teachers to increase teacher retention rates and how many teachers participate in the training while staying in the profession will be a measurable outcome.
