4. Project/Program Description

The Parks & Police 4 Kids, Inc. partners with the City of Doral Police Department, Parks Department, and local schools to provide structured after-school programs for at-risk students. These programs offer academic support, sports, and activities that boost self-esteem, foster engagement, and build positive relationships with law enforcement. Addressing the risks of unsupervised after-school hours, PP4K reduces dropout rates and tracks success through improved grades, graduation rates, and reduced arrests. The Doral Police Explorer Program adds mentorship and career pathways, while former participants give back through community service, reinforcing the program's lasting impact on students and the community.

The requested funds will support PP4K's afterschool program, providing at-risk middle school students with academic assistance, structured activities, and mentorship. By fostering positive self-esteem, engagement, and community involvement, the program helps reduce dropout rates and strengthens student success, ensuring a safe, supportive environment that promotes academic and personal growth.

b. What activities and services will be provided to meet the intended purpose of these funds?

PP4K's afterschool program provides academic support, supervised activities, and sports to at-risk middle school students. Teachers and police officers facilitate structured two-hour sessions, alternating between tutoring and outdoor activities. Students engage in mentorship, community service, and leadership programs like the Explorer Program, fostering positive relationships, accountability, and future career pathways.

c. What direct services will be provided to citizens by the appropriation project?

The appropriation project will provide at-risk middle school students with direct services, including academic tutoring, mentorship from teachers and police officers, supervised sports and recreational activities, and community service opportunities. The program ensures a safe, structured afterschool environment that fosters academic success, positive social development, and career exploration through initiatives like the Explorer Program.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population for this project is at-risk middle school students in the City of Doral who need academic support, mentorship, and structured afterschool activities. The program focuses on students vulnerable to academic disengagement and social challenges. Approximately 100 students per year are expected to benefit from these services, promoting their academic success, personal development, and community engagement.

The expected benefits of this project include improved academic performance, increased student engagement, reduced dropout rates, and stronger community ties. Outcomes will be measured through student grades, graduation rates. participation levels, arrest records, and employment tracking. Success will also be assessed by student involvement in mentorship programs, community service, and the Doral Police Department's Explorer Program.
