Historically, during moderate to heavy rainfall events, the Riverdale community experiences heavy inundation within the roadways. The project includes installation of storm drainage piping, exfiltration trenches, catch basins and inlets, and pavement restoration. The project will provide critical drainage capacity for storm-water runoff, thereby reducing flooding of roadways within the community. The project will improve stormwater management, increase safety and security of people and property and enhance the quality of lives of residents of the community.
