Safety of our responders is first priority at Baker Fire District. Currently, our communications system is aged and is being replaced by the county. However, we are not receiving enough replacement radios to meet operational demands. The cost to replace the new P25 compliant radios will be nearly eight times the cost of our old systems, putting a significant strain on a budget that is focused on purchasing fire suppression apparatus and responder gear for an expanding rural community. We are requesting funding to purchase this critical communications equipment.
