4. Project/Program Description

Since 2013, Links to Success has provided college and career prep programs students in DeSoto County, where economic hardships and limited resources create significant barriers. With 21% of residents living below the poverty line and only 11.6% holding a bachelor's degree (compared to 31.5% statewide), many face major challenges in achieving success. To expand our impact, we now support children earlier through the First 1000 Days initiative, ensuring families receive critical support during pregnancy and early childhood when 80% of brain development occurs. A Family Navigator connects families to essential services. Hurricane lan worsened existing challenges in education, housing, and healthcare, making it even harder for families to access resources. In response, Links to Success is establishing a Family Empowerment Center—a centralized hub program and resources to help families have better outcomes. This request to support the initiation of this center.

a. What specific purpose or goal will be achieved by the funds requested?

DeSoto County faces a significant gap, with graduation rates 15% below the state average and a 20% deficit in college graduates. To bridge this disparity, Links to Success is committed to expanding our programs to serve the entire family. Our new family empowerment center will serve as a centralized resource hub, consolidating essential services and providing families access to critical programs in education, early childhood development, and parenting support.

b. What activities and services will be provided to meet the intended purpose of these funds?

Links to Success will utilize the allocated funds to provide a diverse range of workshops and activities for students and parents in the College and Career Prep and Youth Empowerment Program, as well as the Parent Leadership Academy. These activities include case management, college tours, career exploration workshops, financial aid assistance, leadership training, and summer camps.

c. What direct services will be provided to citizens by the appropriation project?

Our workshops are offered to residents entirely free of charge, ensuring accessibility to all, regardless of their economic circumstances. What makes the Links to Success program particularly impactful is its inclusion of families in various workshops and events.

d. Who is the target population served by this project? How many individuals are expected to be served?

Links to Success is designed to serve a specific target population of students and families who meet specific criteria. Our programs primarily caters to people from economically disadvantaged backgrounds, as indicated by their poverty level. Additionally, the program targets first-generation college students who are breaking new ground in their families by pursuing post-secondary education.
