#### 4. Project/Program Description

The City of Bartow requests funds to replace a 21-year-old front-line fire rescue truck, which has exceeded its useful life. The repairs to keep this critical fire fighting equipment operational are proving to be difficult as parts are not readily available, the truck is not reliable and is out of service for long periods of time. A new fire rescue truck carries tools and equipment needed for forcible entry, ventilation, salvage, overhaul and lighting and utility control. Bartow serves as Polk County's Capital Seat and continues to experience growth. It's essential to have reliable equipment to protect, save lives and property, to meet the needs of the community and the Insurance Services Office (ISO). The ISO 5 rating would be maintained.

#### a. What specific purpose or goal will be achieved by the funds requested?

Purchase new fire rescue truck in order to provide reliable and consistent fire rescue services as is the responsibility of the City of Bartow (City) which serves as Polk County's Capital City. Current first out engine is 21 years old and has exceeded its useful life and is no longer reliable. The ISO 5 rating would be maintained.

#### b. What activities and services will be provided to meet the intended purpose of these funds?



To purchase a new fire rescue truck through the City's procurement policies and procedures. Services provided with a new fire rescue truck provides for first responders to address the increasing demand and to have reliable fire rescue tools and equipment necessary to conduct forcible entry, ventilation, salvage, overhaul, lighting and utility control situations in order to efficiently and effectively save lives, protect properties include state, regional and Federal government buildings and the environment.

#### c. What direct services will be provided to citizens by the appropriation project?

Direct services to citizens is having reliable, fire fighting rescue equipment to save and protect the lives of first responders, citizenry, businesses, schools, State/Federal/local government buildings and properties in this vastly growing community. Respond more effectively to fires, accidents and other incidents where there are risks to life and property with reliable front line fire rescue truck to address increasing demand that has appropriate tools and equipment necessary to conduct forcible entry, ventilation, salvage, overhaul, lighting and utility control situations. Meet the general criteria of NFPA1901 Standard for Automotive Fire Apparatus; The ISO 5 rating would be maintained.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The target population is the City of Bartow, which serves as Polk County's Capital City, citizenry, visitors and travelers, Regional, Federal and State government offices, agencies, properties and buildings, which are tax exempt creating a reduction of revenue that is needed to adequately serve its citizenry and surrounding communities. It is estimated more than 100,000 individuals are expected to be served. The ISO 5 rating would be maintained.

#### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

Expected benefit is the purchase, delivery and operation of reliable fire rescue front line truck that is essential for the protection of the general public, first responders, life, property and the environment. The new fire rescue life saving truck provides first responders reliable equipment to address the increasing demand and to have the appropriate tools and equipment necessary to conduct forcible entry, ventilation, salvage, overhaul, lighting and utility control situations. The ISO 5 rating would be maintained. Measure is efficient and effective response to emergencies, less expenses for maintenance and fuel costs, saving of lives, health and property including regional, State and Federal buildings, as Bartow serves as Polk County's Capital City. The ISO 5 rating would be maintained.
