13. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?



To increase the number of foster youth who are able to graduate high school or achieve a GED degree with reading competency so they can become productive members of society. Currently less than 30% of foster youth will complete high school. This funding will allow us to expand our reading and educational tutoring for all grade levels as well as launch our GED program.

b. What activities and services will be provided to meet the intended purpose of these funds?

New sites will increase access for foster youth to the in-person tutoring and support needed to fill the gaps in their education caused by trauma, regular moves between group and other foster homes, etc. Educational psych testing will identify learning disorders and other challenges that can be addressed with proper tools and support. Our remote help system will be improved to serve more youth.

c. What direct services will be provided to citizens by the appropriation project?

Those in or having been foster care will receive personalized educational support and mentoring including literacy and subject-specific tutoring, educational testing, and degree/GED tracking. Less than 30% of foster youth complete a high school or equivalent degree. Similarly, less than 30% can read and comprehend on a level to get through the basics needed in adulthood.

d. Who is the target population served by this project? How many individuals are expected to be served?

Target populations are youth 22 and under who are or were a part of the foster care system Florida. We expect to serve 201-400 youth this fiscal year while scaling to serve exponentially more in years to come.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Expected outcomes include improved physical and mental health, improved education levels and success, improved job readiness, etc. while reducing likelihood of substance abuse, human trafficking (over 84% of foster kids are trafficked), economic dependency in adulthood, etc. Outcomes will be measured by improved internal and external testing scores, gualitative reports, increased rates of graduation, and increased rates of employment once in adulthood.
