The requested funds will assist in the construction of Phase 1 of the Hopkins Park Masterplan. Phase 1 consists of the construction of a new Community Center that houses an important after-school program in a historically disadvantaged area of the City. The City is investing over \$10,000,000 for the construction of the center and associated infrastructure.

#### c. What direct services will be provided to citizens by the appropriation project?

The requested funds will aid in the construction of the infrastructure needed to directly support an after-school program in a historically disadvantaged area of the City.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

This development will target at-risk youth, developmentally disabled, and pre-school and grade school students that participates in the after-school program, along with every resident and visitor of the City of St. Cloud. The afterschool program houses over 50 students in an economically disadvantaged area within a City of over 70,000 residents.

This project is expected to improve the quality of education, improve physical health, and enrich cultural experience for many of its program participants. This can be easily tracked through community surveys, a review of participant school grades, and community events participation.
