a. What specific purpose or goal will be achieved by the funds requested?

The Senior Enrichment and Wellness Program (SEWP) will enhance senior health, social engagement, and accessibility by funding fitness classes, enrichment trips, sports leagues, and workshops on technology, finance, and arts. Transportation assistance ensures participation, reducing isolation, healthcare costs, and dependency on Medicaid, while promoting active aging and community involvement.

b. What activities and services will be provided to meet the intended purpose of these funds?



The Senior Enrichment and Wellness Program (SEWP) will provide a range of activities and services to enhance senior health, social engagement, and overall well-being. Monthly enrichment trips will offer cultural and recreational experiences, while weekly wellness programs, including yoga, tai chi, and strength training, will promote physical health. Senior sports leagues such as pickleball and bocce will encourage active lifestyles, and social workshops covering technology, financial literacy, and arts education will support lifelong learning and independence. To ensure accessibility, door-to-door transportation services will be available for participants with mobility challenges. These services will foster active aging, reduce isolation, and lower healthcare costs, ultimately improving seniors' quality of life.

c. What direct services will be provided to citizens by the appropriation project?

The Senior Enrichment and Wellness Program (SEWP) will provide direct services that enhance senior health, mobility, and social engagement. These include monthly enrichment trips to cultural and recreational sites, weekly fitness classes such as yoga and strength training, and senior sports leagues like pickleball and bocce. Additionally, social workshops on technology, financial literacy, and creative arts will promote lifelong learning. To ensure accessibility, door-to-door transportation services will be available for participants with mobility challenges. These services will help seniors stay active, reduce isolation, and improve overall well-being, ultimately lowering healthcare costs and supporting independent living.

d. Who is the target population served by this project? How many individuals are expected to be served?

The Senior Enrichment and Wellness Program (SEWP) is designed to serve Orlando residents aged 60 and older, with a focus on those living on fixed incomes. The program aims to engage at least 300 seniors annually through various activities and services that promote health, social engagement, and overall well-being. This initiative aligns with Orlando's commitment to being an age-friendly community, as highlighted in the city's participation in the AARP Network of Age-Friendly States and Communities.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

The Senior Enrichment and Wellness Program (SEWP) aims to improve physical health, mental well-being, cultural engagement, and economic empowerment for seniors in Orlando. Physical health improvements will be measured through pre- and post-program health surveys, assessing mobility, pain levels, and activity levels. Mental health benefits will be tracked using quarterly wellness assessments and satisfaction surveys to measure reductions in stress and loneliness. Cultural enrichment will be evaluated through attendance tracking and post-trip participant feedback surveys after each enrichment outing. Additionally, economic activity will be assessed through pre/post surveys, follow-ups at three and six months, and attendance tracking for financial literacy and estate planning workshops. These measurement tools ensure the program effectively enhances senior well-being, fosters social engagement, and reduces long-term healthcare costs.
