### 4. Project/Program Description

Construction of a centralized facility to provide disaster volunteer services, including preparedness, resources, response, relief, recovery, resiliency, and mitigation in Hardee County. The purpose of the funds will be used to relocate current operations and to expand warehouse facilities. Building will be used to train and coordinate disaster relief volunteers, store donated goods, store and maintain relief equipment (i.e. chainsaws, skid steers, tools, etc), and provide office space for recovery partners (i.e. Long Term Recovery Group, Disaster Case Managers, Construction Coordinators, Volunteers, etc). SendMeMissions, Inc. actively assists Hardee County and each local municipality with disaster services. This request is for construction of a Disaster Volunteer Headquarters.

The purpose of these funds will be to relocate current operations from multiple offices and rented storage spaces. This site will serve as the headquarters for disaster volunteers (local & out-of-state) volunteering in Hardee County to assist with preparedness, resources, relief, recovery, resiliency, and rebuilding from natural and man-made disasters. The goal is to provide safe, sanitary, and secure housing for vulnerable populations in the aftermath of natural and man-made disasters and provide preparation support for all future hurricane seasons by maximizing assistance through donated goods and volunteer labor.

Funds used for contractual services for construction.

Citizens affected by natural and man-made disasters will receive donated materials, skilled volunteer labor, and designated resources and programs to restore safe, sanitary, and secure housing in order to maximize recovery and resiliency in the county.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

Target populations in Hardee County include: elderly, persons with poor physical/mental health, jobless persons, economically disadvantaged, at-risk youth, homeless, developmentally/physically disabled, students (pre-school, grade school, high school, university/college).

## e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

The outcome from this project is to have one centralized location for Hardee County to train and coordinate disaster relief volunteers, store donated goods, store and maintain relief equipment (i.e. chainsaws, skid steers, tools, etc), and provide office space for recovery partners (i.e. Long Term Recovery Group, Disaster Case Managers, Construction Coordinators, Volunteers, etc). Methodology by which the outcome will be measured will be a construction timeline with anticipated completion date of 6/1/2026 prior to the 2026 hurricane season.


