4. Project/Program Description

Miami-Dade County's Department of Transportation and Public Works' Vision Zero goal is to end traffic fatalities and serious injuries by 2040, while increasing safe, reliable, sustainable, and equitable mobility for all. Grand Avenue was identified in the 2021 Vision Zero Framework Plan as a high-injury crash location. This project seeks the construction of roadway safety improvements that include the installation of rapid flashing beacons, intersection medians, high-visibility crosswalks, installation of bike facilities, and upgrades to existing traffic signal countdown timers and pedestrian push buttons. These safety countermeasures are aimed at eliminating the number of fatalities and serious injuries taking place on this corridor.

The project will improve traffic safety for a portion of Grand Ave. by funding design and construction of safety countermeasures adjacent to GW Carver schools. These safety countermeasures are aimed at reducing the number of fatalities and serious injuries taking place on this street. The project will construct safety improvements including the installation of rapid flashing beacons, high-visibility crosswalks, bulb outs and upgrades to existing traffic signal countdown timers.

b. What activities and services will be provided to meet the intended purpose of these funds?

The funds will be used to design and build traffic safety improvements on Grand Ave. The improvements will make the street safer for students of nearby schools as well as residents of the community.

c. What direct services will be provided to citizens by the appropriation project?

The funds will be used for design and construction of traffic safety improvements.

d. Who is the target population served by this project? How many individuals are expected to be served?

Students and residents within the area. Over the course of several years after construction, thousands of people could benefit from improved safety and mobility on the corridor.

These safety improvements will enhance transportation conditions for all users, including those accessing schools and businesses. The outcome will be measured by the elimination of documented crash incidents within the project area, as well as by achieving compliance with current safety standards.


