4. Project/Program Description

The City of Labelle is scheduled to replace their wastewater treatment facility in the next two years. As part of the replacement, the City will be relocating the facility which will require a new master lift station to be constructed at the site of the current facility. The lift station will move wastewater to the new facility through a new force-main capable of meeting current and future demands of the City. This project will also allow the City to meet conditions in the consent order from FDEP (OGC Case No.: 22-2259). The MLS was identified in the Resilient Florida Vulnerability Assessment as a high priority/extreme sensitive asset. Additionally, the City of LaBelle is located in the Caloosahatchee Rive and Estuary BMAP. The Caloosahatchee River and Estuary are impaired for dissolved oxygen (DO), total phosphorus (TP), and total nitrogen (TN). By mitigating the occurrence of SSO's, the project will assist in the state meeting the milestones of the BMAP executive order.

By relocating the current WWTF and installing a new Mast Lift Station at the old WWTF location, it will allow the City to avoid SSO's during extreme weather and comply with the FDEP consent order (OGC Case No.: 22-2259) regarding SSO's. This will also assist in the reduction of total nitrogen and total phosphorus entering the Caloosahatchee River and Estuary BMAP. The MLS was identified in the Resilient Florida Vulnerability Assessment as a high priority/extreme sensitive asset. Methodology will be done via FDEP Permitting.
