**4. Project/Program Description**

Hendry County (County) is requesting funding to construct a public safety station to serve the Flaghole and Montura communities which are located in an outlying area of the County west of Clewiston. The new station will improve services, including faster response times, to residents in outlying areas while also allowing first responders to stage in their station during hurricanes, allowing responders to resume responses to these areas. There are currently two EMS stations in Hendry County which are over 31 miles apart. With the growth the County has experienced, there is need for additional facilities. This new station will be strategically located near US27, and with the capacity to house EMS, fire and sheriff's personnel, will allow for faster response times for our constituents during emergencies on blue sky days as well as hurricanes. As a rural community, Hendry County needs to be able to better facilitate response times in emergencies for life safety purposes.

Increased Fire, EMS, and Sheriff's deputy coverage while allowing emergency personnel to stage in their stations during a major storm event, which is not possible at this time due to current facility not rated for storm events.

Construction of the station will provide faster emergency response times to residents and visitors on blue sky days as well as during a major storm event.
