#### 4. Project/Program Description

Hernando Beach is a coastal community located along canals and channels directly connected to the Gulf of Mexico. The area is highly vulnerable to storm surge and coastal flooding due to its low elevation and proximity to sea level. The entire community lies within FEMA-designated Coastal Flood Zones, making the area particularly susceptible to flooding and its associated environmental impacts.

The project aims to enhance the wastewater infrastructure's resiliency against these climate-related threats, reducing the potential for system failures, ensuring proper wastewater management during extreme weather events, and preventing the environmental contamination that could result from system overflow or failure.
