#### 13. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

Build resilience center: Promote adult ESOL, workforce development, community health, and literacy programs to 1-Increase Community Resilience-Fortify center to offer a centralized site for services, response, resources, and engagement during crises. 2-Improve Understanding of Resilience-Develop/deliver programs to educate residents on strategies to foster informed and proactive community stewardship. 3Promote Community Development-Leverage area opportunity zones to foster economic development.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Fortify and invest in programming for a faith-based, community-led effort and fortify resilience hub that combines civics and health literacy to increase resilience, reduce dependency on government assistance, and improve health outcomes while driving economic development. Addresses workforce readiness, financial independence, and health disparities by empowering individuals with essential skills, resources, and support to build long-term stability.

#### c. What direct services will be provided to citizens by the appropriation project?

Resilience and pastoral care with civics and adult ESOL improve employment opportunities and workplace integration. Programs will support families and foster sustainability and self-sufficiency. Disaster preparedness training will equip families with resilience strategies. Job upskilling initiatives will connect individuals with career pathways and stimulate local economic development.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

1,000 unduplicated households per year consisting of seniors, persons with poor mental health, persons with poor physical health, jobless persons, economically disadvantaged persons, at-risk youth, homeless, school aged children in a community recovering from multiple natural disasters compounded by existing vulnerabilities. The community has multiple established economic opportunity zones established in service area. The area has the resources to promote self-sufficiency in this community through economic opportunity.

## e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

Benefits include enhanced individual economic self sufficiency through wrap around workforce development programs that focus on improved physical through community health workers and mental health through support, improve quality of education through after school programs for both public, charter, and private schools; and protect general public from harm from natural disasters. Performance measures include on-time and on-schedule, surveys, specifics goals and targets that support overall goal of servings 1000 households yearly.

# f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

Award a Firm Fix Price Contract with progress payments and 25% advance. Withhold payments and initiate collections if milestones remain unmet. The agency could also mandate corrective action plans, bar the contractor from future solicitations, and require frequent progress reports. Such measures promote accountability and safeguard taxpayer funds.
