#### 4. Project/Program Description

The sports fields at the center of the City were constructed on a closed landfill that operated until the early 1970s. The fields have begun to give way and restoration includes removal of the top 3' of soil from the 8-acre area, disposal of any waste encountered, and installation of a reinforced geotextile membrane layer, then replacement of the soil and rebuild of the fields and parking lot. This project will allow children and adults to safely play sports on these critical fields.

#### 13. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

The purpose of this project is to restore the City's main sports fields so they can be safely used by youth and adults not only from Port Orange, but all of Volusia County. These fields are in the City Center Complex that also includes City Hall, a County regional library, the YMCA, a Fire Station, and other administration buildings for the City.

#### b. What activities and services will be provided to meet the intended purpose of these funds?



The City has the highest number of participants in field sports in Volusia County and these multi-purpose fields anchor the City Center Complex. This funding will be utilized to restore the City Center sports fields used for youth and adult sports, including baseball and soccer. The City also hosts special needs and preschool sports programs. Fields are also used for partner sports groups, open play by the public, and other special events.

#### c. What direct services will be provided to citizens by the appropriation project?

The fields are used for youth and adult sports seasons. The leagues include youth baseball/softball (738 participants), youth soccer (587), youth flag football (403), and adult kickball (156). We also host special needs and preschool sport programs. Fields are also used for partner sports groups, open play for the public, and special events.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

There are 1,843 youth participating in leagues and 156 adults participate in programs at this site.

#### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The expected benefit of the project is the safe use of the ballfields by the City's youth and adults sports and programs.
