4. Project/Program Description

Road flooding occurs during medium to heavy rainfall events - preventing residents from entering or leaving Baywood Drive. This is a dangerous condition preventing emergency service access in and out of Baywood Drive. Roadway and drainage improvements will provide access for residents and emergency service vehicles during such rainfall events. Baywood Drive is a "Dead End Street" approximately 1.05 miles in length with only one ingress/egress access to County Road 67 (Tallahassee Street).

13. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Roadway and drainage improvements on Baywood Drive to alleviate street flooding and improve vehicular and pedestrian passage to County Road 67 (Tallahassee Street) during periods of high water across the roadway. Baywood Drive is a "Dead End Street" approximately 1.05 miles in length with only one ingress/egress access to County Road 67 (Tallahassee Street). The street flooding occurs during medium to heavy rainfall events resulting in limited to no access to the properties along Baywood Drive.

b. What activities and services will be provided to meet the intended purpose of these funds?

The activities and services provided include roadway grading, paving, drainage improvements and storm drain culverts. Along with general roadway upgrade and improvements required to achieve the project goal.

c. What direct services will be provided to citizens by the appropriation project?

The proposed improvements will create passable and safe access to their properties and homes along Baywood Drive with improved access during high water storm events.

d. Who is the target population served by this project? How many individuals are expected to be served?

This project serves the residents along Baywood Drive and those that utilize Baywood Drive to access their properties. There are 40 properties (approximately 100 residents) that are accessed on Baywood Drive.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Currently the roadway is not passable during flooded conditions. Residents are not able to enter or exit their homes during these conditions. The proposed improvements will create passable and safe access to their properties and homes along Baywood Drive. Improved access on Roadway to adjacent properties during high water storm events. Street flooding will be alleviated.

Liquidated Damages for Failure to Complete the Work. Highway Code Requirements Pertaining to Liquidated Damages requires that the Department adopt regulations for the determination of default and provides that the Contractor pay liquidated damages to the Department for any failure of the Contractor to complete the Contract work within the Contract Time. These Code requirements govern, and are made a part of the Contract.

Liquidated Damages: \$500,000 but less than \$2,500,000: \$1,694/day


