

1                   A bill to be entitled  
2           An act relating to license plates; amending ss.  
3           320.08056 and 320.08058, F.S.; creating a Keep  
4           Kids Drug Free license plate; creating a  
5           Florida Sheriffs Youth Ranches license plate;  
6           providing for the distribution of annual use  
7           fees received from the sale of such plates;  
8           providing an effective date.

10   Be It Enacted by the Legislature of the State of Florida:

12           Section 1. Paragraphs (t) and (u) are added to  
13   subsection (4) of section 320.08056, Florida Statutes, to  
14   read:

15           320.08056 Specialty license plates.--  
16           (4) The following license plate annual use fees shall  
17   be collected for the appropriate specialty license plates:  
18           (t) Keep Kids Drug Free license plate, \$25.  
19           (u) Florida Sheriffs Youth Ranches license plate, \$20.

20           Section 2. Subsections (20) and (21) are added to  
21   section 320.08058, Florida Statutes, to read:

22           320.08058 Specialty license plates.--  
23           (20) KEEP KIDS DRUG FREE LICENSE PLATES.--  
24           (a) The department shall develop a Keep Kids Drug Free  
25   license plate as provided in this section. The word "Florida"  
26   must appear at the top of the plate, and the words "Keep Kids  
27   Drug Free" must appear at the bottom of the plate.  
28           (b) The annual use fees shall be distributed to the  
29   Keep Kids Drug-Free Foundation, Inc., which shall use the fees  
30   to fund activities to reduce substance abuse among residents

1 of this state. The foundation shall develop a plan to  
2 distribute the funds for drug-abuse prevention programs.

3 1. Notwithstanding s. 320.08062, up to 10 percent of  
4 the proceeds from the annual use fee may be used for marketing  
5 the Keep Kids Drug Free license plate and administrative costs  
6 directly related to the management and distribution of the  
7 proceeds.

8 2. The remaining proceeds from the annual use fee  
9 shall be used for programs and activities to reduce substance  
10 abuse among Florida residents.

11 (21) FLORIDA SHERIFFS YOUTH RANCHES LICENSE PLATES.--

12 (a) The department shall develop a Florida Sheriffs  
13 Youth Ranches license plate as provided in this section. The  
14 word "Florida" must appear at the top of the plate, and the  
15 words "Sponsored by the Florida Sheriffs Association" must  
16 appear at the bottom of the plate. The Florida Sheriffs Youth  
17 Ranches logo must appear on the left quarter of the plate,  
18 surrounded by the words "Florida Sheriffs Youth Ranches," and  
19 the words "Preventing delinquency since 1957" must appear  
20 below the numerals on the plate.

21 (b) The annual use fees shall be distributed to the  
22 Florida Sheriffs Youth Ranches, Inc., for its operations.

23 Section 3. This act shall take effect July 1 of the  
24 year in which enacted.
