LEGISLATIVE SUMMARY Creates the "Jeremy Fiedelholtz Safe Day Care Act." Increases the penalty for violations relating to licensure or operation of a day care facility or family day care home, or misrepresenting one's qualifications with respect thereto, from a first degree misdemeanor to a third degree felony. Provides a third degree felony penalty for making other misrepresentations to certain persons regarding such licensure or operation or for violating requirements relating to the staff-to-children ratio or the number of children at the facility. Provides a second degree felony penalty in the event a violation results in great bodily harm, permanent disability, or permanent disfigurement. Provides for ranking of violations on the offense severity ranking chart.
