Subsection (1) of section 320.08053, 18 19 Florida Statutes, is amended to read: 20 320.08053 Requirements for requests to establish 21 specialty license plates .--22 (1) An organization that seeks authorization to 23 establish the establishment of a new specialty license plate 24 for which an annual use fee is to be charged must submit to 25 the department: (a) A request for the particular specialty license 26 27 plate being sought, describing the proposed specialty license 28 plate in general terms. 29 The results of a scientific sample survey of 30 Florida motor vehicle owners which indicate at least 15,000

The sample survey of registered motor vehicle owners must be performed independently of the requesting organization by an organization that conducts similar sample surveys as a normal course of business. Prior to conducting a sample survey for the purposes of this section, a requesting organization must obtain a determination from the department that the organization selected to conduct the survey performs similar surveys as a normal course of business and is independent of the requesting organization. A petition, on a form approved by the department, signed by 10,000 or more residents who state their intent to purchase the requested specialty license plate.

- (c) An application fee, not to exceed \$60,000 \$30,000, to defray the department's cost for reviewing the application and developing the specialty license plate, if authorized.

 State funds may not be used to pay the application fee, except for collegiate specialty license plates authorized in s.

 320.08058(3) and (13).
- (d) A marketing strategy outlining short-term and long-term marketing plans for the requested specialty license plate and a financial analysis outlining the anticipated revenues and the planned expenditures of the revenues to be derived from the sale of the requested specialty license plates.

The information required under this subsection must be submitted $\underline{\text{to the department}}$ at least 90 days before the convening of the next regular session of the Legislature.

Subsections (8) and (9) of section 320.08056, Florida Statutes, are amended, and subsection (10) 2 3 is added to said section, to read: 320.08056 Specialty license plates.--4 5 (8)(a) The department must discontinue the issuance of 6 an approved specialty license plate if: 7 1. Less than 8,000 plates are issued for that 8 specialty license plate by the end of the 5th year of sales. 9 2.  before the end of the 5th year unless the inventory of those plates has been depleted. However, the organization may purchase the remaining inventory of the specialty license plates from the department at cost.

(10) A specialty license plate annual use fee collected and distributed under this chapter, or any interest earned from those fees, may not be used for commercial or for-profit activities nor for general or administrative expenses, except as authorized by s. 320.08058 or to pay the cost of the audit or report required by s. 320.08062(1).

Section 3. Section 320.08062, Florida Statutes, is amended to read:

320.08062 Audits required; annual use fees of special license plates.--

(1) (a) All organizations that receive annual use fee proceeds from the department are responsible for ensuring that proceeds are used in accordance with ss. 320.08056 and 320.08058.

(b) All organizational recipients of any specialty license plate annual use fee authorized in this chapter, not otherwise subject to annual audit by the Office of the Auditor General, shall submit either an annual or biennial audit of the expenditures of annual use fees and interest earned from these fees, to determine if expenditures are being made in accordance with the specifications outlined by law. The audit shall be prepared by a certified public accountant licensed under chapter 473 at that organizational recipient's expense. The notes to the financial statements should state whether expenditures were made in accordance with ss. 320.08056 and 320.08058. Such audits shall be delivered to the President of the Senate, the Speaker of the House of Representatives, the

Office of the Governor, and the department no later than December 31 of the calendar year in which the audit was performed.

- (c) In lieu of an annual audit, any organization receiving less than \$25,000 in annual use fee proceeds directly from the department may annually report, under penalties of perjury, that such proceeds were used in compliance with ss. 320.08056 and 320.08058. The attestation shall be made annually in a form and format determined by the department.
- (d) The annual audit or report shall be submitted to the department for review within 180 days after the end of the organization's fiscal year.
- (2) A specialty license plate annual use fee collected and distributed under this chapter, or any interest earned from those fees, may not be used for commercial or for-profit activities nor for general or administrative expenses, except to pay the cost of the independent audit required by subsection (1).
- organization's audit or report By February 1 of each year, the department shall determine which recipients of revenues from specialty license plate annual use fees have not complied with subsection (1). If the department determines that an organization has not complied with subsection (1)or has failed to use the revenues in accordance with ss. 320.08056 and s.320.08058, the department must may discontinue the distribution of the revenues to the organization until the department determines that the organization has complied is complying with those provisions. If an organization fails to comply within 12 months after the annual use fee proceeds are

withheld by the department, the proceeds shall be deposited into the Highway Safety Operating Trust Fund to offset department costs related to the issuance of specialty license plates. (3) (4) The Auditor General and the department have has the authority to examine all records pertaining to the use of funds from the sale of specialty license plates. Section 4. This act shall take effect upon becoming a law. LEGISLATIVE SUMMARY Revises provisions of law governing the issuance of specialty license plates to require scientific sample surveys of registered motor vehicle owners prior to the issuance of such plates, to authorize an increase in the initial application fee by an organization for the issuance of such plates, and to revise provisions issuance of such plates, and to revise provisions relating to the discontinuance of such plates.
