## I. <u>SUMMARY</u>:

The bill repeals special acts relating specifically to the Hillsborough County City-County Planning Commission, and provides they be consolidated and codified. The bill also provides for periodic review and recodification.

#### II. SUBSTANTIVE RESEARCH:

#### A. PRESENT SITUATION:

The Hillsborough County City-Planning Commission (Commission) was created by special act, chapter 78-523. It was created for the purpose of conducting continuous planning, and making recommendations to the Board of County Commissioners of Hillsborough County, and other appropriate bodies concerning the orderly growth and development of Hillsborough County.

It is the duty of the Commission to prepare periodic reports on the comprehensive plans adopted by Hillsborough County, the City of Tampa, and participating municipalities as required by the Hillsborough County Local Government Comprehensive Planning Act of 1975. In developing and implementing comprehensive plans, the Commission must utilize a process which ensures that citizens in local communities can initiate and participate in the development and implementation of said comprehensive plans.

The Commission has the authority to: (1) enter into contracts and agreements; (2) hold public hearings and sponsor public forums; (3) accept and expend funds and grants, and accept and use services from federal, state and county governments or their agencies; (4) to perform other planning services upon the request of the municipal or county governments of Hillsborough County; and (5) make expenditures for the purpose of required equipment and supplies to carry out the purpose of its creating act.

Currently, laws pertaining specifically to the Commission are not codified, and some provisions duplicate provisions of Florida Statutes.

B. EFFECT OF PROPOSED CHANGES:

Laws relating specifically to the Commission will be consolidated and codified. Future laws relating specifically to the Commission will be reviewed and recodified, as necessary.

#### E. SECTION-BY-SECTION RESEARCH:

<u>Section 1.</u> Provides that this act supersedes:

- Chapter 78-523, Laws of Florida, which provides for the establishment of the Hillsborough County City-County Planning Commission;
- Chapter 75-390, Laws of Florida, as amended, which creates the Hillsborough County Local Government Comprehensive Planning Act of 1975;
- Chapter 67-1507, Laws of Florida, as amended, relating to the review of capital improvements budgets of Hillsborough County and its municipalities; and
- Chapter 94-406, Laws of Florida, as amended, relating to the requirement for a periodic performance audit of the Hillsborough County City-County Planning Commission.

Provides for codification of the previously existing legislation, and deletes provisions which have expired or have had their effect or have been impliedly repealed or superseded.

<u>Section 2</u>. Creates the Hillsborough County City-County Planning Commission (Commission) for the purpose of conducting continuous planning and making recommendations of the Board of County Commissioners. Provides that the

Commission is the single local planning agency for Hillsborough County and its municipalities, and delineates its duties.

<u>Section 3</u>. Provides for the terms, meetings, and methods of appointment of the members of the Committee.

Section 4. Describes the powers of the Commission.

<u>Section 5</u>. Provides notification requirements if a proposed future land use element or amendment thereto involves less than 5 percent of the total land area of the local government unit. Provides procedures for amendment of an adopted comprehensive plan. Provides procedures for capital improvements budgeting and priorities which must be followed by each local government. Provides definitions for terms used in the section.

<u>Section 6</u>. Provides that any authority exercising planning or land development powers shall submit to the Commission its long-range and master plans and cooperate with the Commission by providing the Commission with necessary information.

<u>Section 7</u>. Provides that the Commission is subject to a performance audit every 4 years. Provides such audit shall be conducted in accordance with Government Auditing Standards and includes audit components and requirements.

<u>Section 8</u>. Provides for recodification and review of this act every 10 years.

<u>Section 9</u>. Provides a severability clause.

<u>Section 10</u>. Repeals chapters 67-1507, 75-390, 75-399, 77-564, 77-566, 78-523, 81-392, 82-303, 83-421, 84-442, 86-407, 94-406 and 96-517, Laws of Florida. Provides that such appeal does not effect the prosecution of any cause of action that accrued before the effective date of the repeal.

Section 11. Provides an effective date of July 1, 1997.
