The word 22 "Florida" must appear at the top of the plate, and the words 23 "Protect Wild Dolphins" may appear at the bottom of the plate. 24 (b) The annual use fees shall be distributed to the 25 26 Harbor Branch Oceanographic Institution, Inc., to fund wild 27 dolphins related research.
