23 320.0848 or ~~and~~ a signed affidavit that the owner of the
24 disabled parking permit or license plate was present at the
25 time the violation occurred, and that such a parking permit or
26 license plate was valid at the time the violation occurred.
27 The law enforcement officer, upon determining that all
28 required documentation has been submitted verifying that the
29 required parking permit or license plate was valid at the time
30 of the violation, must sign an affidavit of compliance. Upon
