Section 316.2015, Florida Statutes, is 11 12 amended to read: 316.2015 Unlawful for person to ride on exterior of 13 14 vehicle.--15 (1) It is unlawful for any operator of a passenger vehicle to permit any person to ride on the bumper, radiator, 16 17 fender, hood, top, trunk, or running board of such vehicle when operated upon any street or highway which is maintained 18 19 by the state, county or municipality. However, the operator 20 of any vehicle shall not be in violation of this section when 21 such operator permits any person to occupy seats securely 22 affixed to the exterior of such vehicle. Any person who violates the provisions of this subsection shall be cited for 23 a moving violation, punishable as provided in chapter 318. 24 25 (2) No person shall ride on any vehicle upon any portion thereof not designed or intended for the use of 26 27 passengers, including the bed of a pickup truck or flatbed 28 truck. This provision shall not apply to an employee engaged 29 in the necessary discharge of a duty or to a person or persons riding within truck bodies in space intended for merchandise. 30 31 Any person who violates the provisions of this subsection 1
