I. SUMMARY:

This proposal would create the Everglades Parkway Construction Trust Fund. The fund will be used by the Department of Transportation to account for Everglades Parkway bond proceeds. The bonds are backed by toll revenues collected on Alligator Alley, and will be used to fund transportation improvements as provided in 1994 legislation related to Everglades restoration.

The bill has no fiscal impact.

II. SUBSTANTIVE RESEARCH:

A. PRESENT SITUATION:

Sections 4 and 5 of chapter 94-115, Laws of Florida, authorizes the department to issue bonds secured by toll revenues collected on Alligator Alley to fund transportation projects contained in any work program adopted in fiscal year 1993-94 or later. These provisions were part of Everglades restoration legislation passed in 1994. The department plans to issue approximately \$60 million in bonds during the 1996-97 fiscal year for projects on Alligator Alley. However, the department does not have an established trust fund to contain and account for the bond proceeds.

B. EFFECT OF PROPOSED CHANGES:

This proposal would create the Everglades Parkway Construction Trust Fund, to be used for revenue bonds backed by toll revenues on Alligator Alley. Failure to establish the trust fund would be contrary to the official bond statement and would cause administrative problems for the Department related to accounting for bond proceeds.
