1 A bill to be entitled An act relating to the State University System; 2 3 designating a building on the campus of Florida 4 International University as "The Sanford and Dolores Ziff and Family Education Building"; 5 6 designating the School of Communication at the 7 University of Central Florida as the "Anthony J. Nicholson School of Communication"; 8 9 designating the president's residence at the University of Central Florida as "The Burnett 10 House"; designating a building on the campus of 11 12 the University of North Florida as the "J. 13 Brooks Brown Hall"; designating the residence hall known as 1st Court, Pei Residence Halls, 14 15 located on the Sarasota Campus of New College of the University of South Florida, as the "Bob 16 17 Johnson Residence Hall"; designating the 18 residence hall known as 3rd Court, Pei Residence Halls, located on the Sarasota Campus 19 20 of New College of the University of South Florida, as the "Elaine and Harvey Rothenberg 21 Residence Hall"; designating the Residence 22 Hall--Phase II being constructed for students 23 24 of New College on the Sarasota Campus of the University of South Florida as the "Ann and 25 26 Alfred Goldstein Residence Hall"; authorizing 27 the respective universities to erect suitable 28 markers; providing an effective date. 29 30 Be It Enacted by the Legislature of the State of Florida:

31

1 Section 1. The Florida International University 2 College of Education Building is hereby designated as "The Sanford and Dolores Ziff and Family Education Building" in 3 honor of business leader, community philanthropist, and 4 5 significant benefactor of Florida International University, 6 Dr. Sanford L. Ziff, and his family. 7 Section 2. The School of Communication at the 8 University of Central Florida is hereby designated as the "Anthony J. Nicholson School of Communication" in recognition 10 of the generosity of Anthony J. Nicholson. Section 3. The president's residence at the University 11 of Central Florida is hereby designated as "The Burnett House" 12 13 in recognition of Al and Nancy Burnett for their support of numerous community activities and their contributions to the 14 15 University of Central Florida, including funds to complete the first president's residence at the university. 16 17 Section 4. The building currently known as Building 18 39, College of Health on the University of North Florida 19 campus is hereby designated as the "J. Brooks Brown Hall" in 20 recognition of the contributions of J. Brooks Brown to the 21 medical community of Jacksonville, as well as his contributions to the University of North Florida. 23 Section 5. The residence hall known as 1st Court, Pei Residence Halls, located on the Sarasota Campus of New College 24 of the University of South Florida, is hereby named the "Bob 25 26 Johnson Residence Hall" in recognition of the tireless and dedicated service of Robert M. (Bob) Johnson to New College, 27 28 to the University of South Florida, to our State University 29 System, and to all of Florida's students, from kindergarten 30 through graduate school. 31

1 Section 6. The residence hall known as 3rd Court, Pei Residence Halls, located on the Sarasota Campus of New College 2 of the University of South Florida, is hereby named the 3 4 "Elaine and Harvey Rothenberg Residence Hall" in recognition of the tireless and dedicated service of Harvey Rothenberg to 5 6 New College and the University of South Florida. 7 Section 7. The Residence Hall--Phase II being 8 constructed for New College of University of South Florida 9 students on the Sarasota Campus of the University of South Florida is hereby named the "Ann and Alfred Goldstein 10 Residence Hall" in recognition of the contributions of Ann and 11 12 Alfred Goldstein to the well-being and betterment of the 13 students of New College of the University of South Florida. The respective universities are authorized 14 Section 8. 15 to erect suitable markers for the designations made by this 16 act. 17 Section 9.
