1 A bill to be entitled
2 An act relating to the State University System;
3 designating a building on the campus of Florida
4 International University as "The Sanford and
5 Dolores Ziff and Family Education Building";
6 designating the School of Communication at the
7 University of Central Florida as the "Anthony
8 J. Nicholson School of Communication";
9 designating the president's residence at the
10 University of Central Florida as "The Burnett
11 House"; designating a building on the campus of
12 the University of North Florida as the "J.
13 Brooks Brown Hall"; designating the residence
14 hall known as 1st Court, Pei Residence Halls,
15 located on the Sarasota Campus of New College
16 of the University of South Florida, as the "Bob
17 Johnson Residence Hall"; designating the
18 residence hall known as 3rd Court, Pei
19 Residence Halls, located on the Sarasota Campus
20 of New College of the University of South
21 Florida, as the "Elaine and Harvey Rothenberg
22 Residence Hall"; designating the Residence
23 Hall--Phase II being constructed for students
24 of New College on the Sarasota Campus of the
25 University of South Florida as the "Ann and
26 Alfred Goldstein Residence Hall"; authorizing
27 the respective universities to erect suitable
28 markers; providing an effective date.

30 Be It Enacted by the Legislature of the State of Florida:
31

1 Section 1. The Florida International University
2 College of Education Building is hereby designated as "The
3 Sanford and Dolores Ziff and Family Education Building" in
4 honor of business leader, community philanthropist, and
5 significant benefactor of Florida International University,
6 Dr. Sanford L. Ziff, and his family.

7 Section 2. The School of Communication at the
8 University of Central Florida is hereby designated as the
9 "Anthony J. Nicholson School of Communication" in recognition
10 of the generosity of Anthony J. Nicholson.

11 Section 3. The president's residence at the University
12 of Central Florida is hereby designated as "The Burnett House"
13 in recognition of Al and Nancy Burnett for their support of
14 numerous community activities and their contributions to the
15 University of Central Florida, including funds to complete the
16 first president's residence at the university.

17 Section 4. The building currently known as Building
18 39, College of Health on the University of North Florida
19 campus is hereby designated as the "J. Brooks Brown Hall" in
20 recognition of the contributions of J. Brooks Brown to the
21 medical community of Jacksonville, as well as his
22 contributions to the University of North Florida.

23 Section 5. The residence hall known as 1st Court, Pei
24 Residence Halls, located on the Sarasota Campus of New College
25 of the University of South Florida, is hereby named the "Bob
26 Johnson Residence Hall" in recognition of the tireless and
27 dedicated service of Robert M. (Bob) Johnson to New College,
28 to the University of South Florida, to our State University
29 System, and to all of Florida's students, from kindergarten
30 through graduate school.

1 Section 6. The residence hall known as 3rd Court, Pei
2 Residence Halls, located on the Sarasota Campus of New College
3 of the University of South Florida, is hereby named the
4 "Elaine and Harvey Rothenberg Residence Hall" in recognition
5 of the tireless and dedicated service of Harvey Rothenberg to
6 New College and the University of South Florida.

7 Section 7. The Residence Hall--Phase II being
8 constructed for New College of University of South Florida
9 students on the Sarasota Campus of the University of South
10 Florida is hereby named the "Ann and Alfred Goldstein
11 Residence Hall" in recognition of the contributions of Ann and
12 Alfred Goldstein to the well-being and betterment of the
13 students of New College of the University of South Florida.

14 Section 8. The respective universities are authorized
15 to erect suitable markers for the designations made by this
16 act.

17 Section 9. This act shall take effect upon becoming a
18 law.
