2 increased his or her grade point average to 2.0 on a 4.0
3 scale. If the student has increased his or her grade point

7 verified and need not wait until the beginning of the next
8 grading period to regain eligibility. Student eligibility for
9 the first grading period of each new school year shall be
10 based on passing five subjects and maintaining the required
11 grade point average the previous school year, including
12 subjects completed during the interim summer school session.~~a~~
13 ~~student entering the 9th grade during the 1997-1998 school~~
14 ~~year and thereafter must maintain a cumulative grade point~~
15 ~~average of 2.0 or above on a 4.0 scale, or its equivalent, in~~
