#### I. SUMMARY:

HB 223, if enacted, will transfer, by a type one transfer as described in s. 20.06, F.S., the Department of Highway Safety and Motor Vehicles (HSMV) (s. 20.24, F.S.) to the Department of State (s. 20.10, F.S.). The three divisions, as currently existing in HSMV, will be established in the Department of State. Also, HB 223 repeals s. 20.24, F.S., relating to the Department of Highway Safety and Motor Vehicles.

Additionally, HB 223 removes references to the Department of Highway Safety and Motor Vehicles found in ss. 316.003 (8), and 318.13 (1), F.S., and replaces them with references to the Department of State.

This bill directs the Division of Statutory Revision of the Joint Legislative Management Committee, in editing manuscript for the next official version of the Florida Statutes, to replace the term "Department of Highway Safety and Motor Vehicles" wherever that term appears in the statutes with the term "Department of State."

Since there are no details in the bill as to how this transfer will be administered, the actual fiscal impact of this bill is indeterminate. It is anticipated that there will be at least a minimal fiscal impact.

# II. SUBSTANTIVE ANALYSIS:

#### A. PRESENT SITUATION:

Section 20.24, F.S., creates a Department of Highway Safety and Motor Vehicles. The head of the Department of Highway Safety and Motor Vehicles is the Governor and Cabinet. The Division of the Florida Highway Patrol, the Division of Motor Vehicles, and the Division of Driver Licenses are divisions within the department.

Section 20.10, F.S., creates the Department of State. The head of the Department of State is the Secretary of State. The Division of Elections, the Division of Historical Resources, the Division of Corporations, the Division of Library and Information Services, the Division of Licensing, the Division of Cultural Affairs, and the Division of Administration are divisions within the department.

Currently, the Department of Highway Safety and Motor Vehicles has responsibilities found in chs. 316, F.S., (State Uniform Traffic Control) and 318, F.S., (Disposition of Traffic Infractions) and reference is made to the Department of Highway Safety and Motor Vehicles in the definition sections of these chapters.

Section 20.06, F.S., establishes the method of reorganization of state government. "The executive branch of state government shall be reorganized by transferring the specified agencies, programs, and functions to other specified departments, commissions, or offices. Such a transfer does not affect the validity of any judicial or administrative proceeding pending on the day of the transfer, and any agency or department to which are transferred the powers, duties, and functions relating to the pending proceeding must be substituted as a party in interest for the proceeding. The transfers provided herein are intended to supplement but not supplant the requirements of s. 6, Art. III(sic) of the State Constitution..."

Article IV, s. 6., of the State Constitution provides "[A]II functions of the executive branch of state government shall be allotted among not more than twenty-five departments, exclusive of those specifically provided for or authorized in this constitution. The administration of each department, unless otherwise provided in this constitution, shall be placed by law under the direct supervision of the governor, the lieutenant governor, the governor and cabinet, a cabinet member, or an officer or board appointed by and serving at the pleasure of the governor,..."

Section 20.06, F.S., provides for the types of transfers to be utilized when reorganizing state government. "A type one transfer is the transferring intact of an existing agency or department so that the agency or department becomes a unit of another agency or a department. Any agency or department transferred to another agency or department by a type one transfer will exercise its powers, duties, and functions as prescribed by law, subject to review and approval by, and under the direct supervision of, the head of the agency or department to which the transfer is made, unless otherwise provided by law. Any agency or department transferred by a type one transfer has all its statutory powers, duties, and functions, and its records, personnel, property, and unexpended balances of appropriations, allocations, or other funds transferred to the agency or department to which it is transferred. The transfer of segregated funds must be made in such a manner that the relation between program and revenue source as provided by law is retained. Unless otherwise provided by law, the administrative rules of any agency or

department involved in the transfer which are in effect immediately before the transfer remain in effect until specifically changed in the manner provided by law."

#### B. EFFECT OF PROPOSED CHANGES:

HB 223, if enacted, will transfer all of the existing legal authorities and actions of the Department of Highway Safety and Motor Vehicles, including the Florida Highway Patrol, by a type one transfer as described in s. 20.06, F.S., to the Department of State. The transfer includes, but is not limited to, all pending and completed action on orders or rules, all enforcement matters, and all delegations, interagency agreements, and contracts with federal, state, regional, and local governments, and private entities. All personnel, property, and unexpended balances of appropriations, allocations, or other funds of the Department of Highway Safety and Motor Vehicles are transferred to the Department of State.

This bill amends s. 20.10, F.S., to add the Division of Driver Licenses, Motor Vehicles, and the Florida Highway Patrol (that are transferred from HSMV) to the list of existing divisions established at the Department of State and repeals s. 20.24, F.S.

References to the Department of Highway Safety and Motor Vehicles are removed from the definition sections of ss. 316.003 (8) and 318.13 (1), F.S., and they are replaced with the Department of State.

Finally, this bill directs the Division of Statutory Revision of the Joint Legislative Management Committee, in editing manuscript for the next official version of the Florida Statutes, to replace the term "Department of Highway Safety and Motor Vehicles" wherever that term appears in the statutes with the term "Department of State."

Although this bill repeals the statute creating the Department of Highway Safety and Motor Vehicles, it transfers all of the existing duties, responsibilities, personnel, property, and appropriations to the Department of State. It does not eliminate them.

This bill transfers intact the existing Department of Highway Safety and Motor Vehicles to the Department of State by a type one transfer.

This bill transfers the personnel, property, and unexpended balances of appropriations, allocations, or other funds of the Department of Highway Safety and Motor Vehicles to the Department of State. This bill does nothing to indicate whether or not there will be increased costs or savings.

- Section 1. By a type one transfer, as described in s. 20.06, F.S., transfers intact the existing Department of Highway Safety and Motor Vehicles to the Department of State.
- Section 2. Amends s. 20.10, F.S., providing for the additional divisions of Driver Licenses, Motor Vehicles, and Florida Highway Patrol in the Department of State.
- Section 3. Repeals s. 20.24, F.S., which created the Department of Highway Safety and Motor Vehicles.
- Section 4. Amends s. 316.003 (8), F.S., to remove a reference to the Department of Highway Safety and Motor Vehicles in the definition section of this chapter and replaces it with the Department of State.

Section 5. Amends s. 318.13 (1), F.S., to remove a reference to the Department of Highway Safety and Motor Vehicles in the definition section of this chapter and replaces it with the Department of State.

Section 6. Directs the Division of Statutory Revision of the Joint Legislative
Management Committee, in editing manuscript for the next official version of
the Florida Statutes, to replace the term "Department of Highway Safety and
Motor Vehicles" wherever that term appears in the statutes with the term
"Department of State."

Section 7. Provides an effective date of upon becoming law.
