I. SUMMARY:

Committee Substitute for House Bill 225 prohibits the Department of Highway Safety and Motor Vehicles from renewing a driver's license if its records show that the driver is the subject of an outstanding warrant for worthless checks. Prior to issuing any driver's license renewal, the Department of Highway Safety and Motor Vehicles must make an electronic inquiry into the records of the Florida Department of Law Enforcement, using the applicant's driver's license number, to determine the existence of any outstanding warrants for passing worthless checks. If there is any such outstanding warrant, the applicant is responsible for contacting the sheriff's office that entered the warrant and satisfying its conditions before the license can be renewed. When the warrant entry is canceled from the Department of Law Enforcement's records by the entering agency, the applicant must pay an additional \$10 fee to the department renewing the applicant's driver's license.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

Currently, an applicant for driver's license renewal may be issued a new driver's license regardless of the existence of an outstanding warrant or capias for passing worthless bank checks, as long as the applicant is in compliance with the requirements set forth in Section 322. 18, Florida Statutes.

B. EFFECT OF PROPOSED CHANGES:

The bill would require that prior to the issuance of any driver's license renewal, the Department of Highway Safety and Motor Vehicles make an electronic inquiry into the records of the Department of Law Enforcement, using the applicant's driver's license number to determine whether there exists any outstanding warrant for passing worthless checks. If the records indicate there is an outstanding warrant for passing worthless checks, no license renewal may be issued. The applicant must contact the sheriff's office that entered the warrant, and satisfy its conditions. The agency which made the entry then cancels it from the records of the Department of Law Enforcement. When this occurs, the applicant must pay an additional \$10 fee payable to the Department of Highway Safety and Motor Vehicles, prior to issuance of a license renewal.

The bill obligates the Department of Highway Safety and Motor Vehicles and Motor Safety to make an electronic inquiry into the records of the Department of Law Enforcement each time an applicant seeks renewal of a driver's license. The Department of Law Enforcement must determine which persons have outstanding warrants for passing worthless checks, in violation of s. 832.05, Florida Statutes, and make the records available to the Department of Highway Safety and Motor Vehicles so that they are retrievable through entry of a driver's license number.

<u>Section 1:</u> Adds Subsection (10) to s. 322.18, Florida Statutes, which prohibits the Department of Highway Safety and Motor Vehicles from issuing a driver's license renewal if records indicate an outstanding warrant for worthless check.

Section 2: Provides an effective date.

IV. CONSEQUENCES OF ARTICLE VII, SECTION 18 OF THE FLORIDA CONSTITUTION:

A. APPLICABILITY OF THE MANDATES PROVISION:

This bill does not require counties or municipalities to spend funds or to take an action requiring expenditure of funds.

B. REDUCTION OF REVENUE RAISING AUTHORITY:

This bill does not reduce the authority that municipalities or counties have to raise revenues in the aggregate.

C. REDUCTION OF STATE TAX SHARED WITH COUNTIES AND MUNICIPALITIES:

VI. AMENDMENTS OR COMMITTEE SUBSTITUTE CHANGES:

CS/HB 225 provided that the Department of Highway Safety and Motor Vehicles would "make an electronic inquiry into the Department of Law Enforcement's records, using the applicant's driver's license number, to determine whether the applicant has an outstanding warrant or capias for passing worthless checks." The committee substitute provides that the Department of Highway Safety and Motor Vehicles and the Florida Department of Law Enforcement "shall develop and implement a plan to ensure the identification of persons who are the subject of an outstanding warrant or capias for passing worthless bank checks and identification of these persons driver license records." This amendment provides for greater flexibility in the sharing of information and identification of individuals subject to the provisions of this bill.
