An act relating to the Town of Davie, Broward County; extending and enlarging the corporate limits of the Town of Davie to include specified unincorporated lands within said corporate limits; redefining the town limits; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

 Section 1. The present corporate limits of the Town of Davie, Broward County, Florida, are hereby extended and enlarged so as to include, in addition to the territory presently within its corporate limits, the area particularly described as follows:
