Section 1. Section 259.1051, Florida Statutes, is created to read:

259.1051 Florida 2020 Trust Fund.--

(1) The Florida 2020 Trust Fund is hereby created, to be held and administered by the Department of Environmental Protection to carry out the purposes of ss. 259.032, 259.105, 373.453, and 373.59 and part III of chapter 380. Funds shall be credited to the trust fund as provided in this section to be used for the purposes set forth herein. This trust fund is a trust fund as provided by s. 19(f)(3), Art. II of the State Constitution and is not subject to termination as required under s. 19(f)(2), Art. II of the State Constitution. All moneys deposited into the trust fund shall be held in trust for the uses and purposes set forth in this section, within

the meaning of s. 215.32(1)(b), and such moneys shall not become or be commingled with the General Revenue Fund.

- (2) Documentary stamp tax revenues on deposit in the trust fund shall be first applied to meet debt service requirements of revenue bonds issued pursuant to s. 259.105, and such funds shall be accounted for separately from those appropriated for other purposes.
- (3) Proceeds from the sale of revenue bonds issued pursuant to s. 19, Art. VII of the State Constitution and s. 259.02, not to exceed \$6 billion, also shall be deposited into the trust fund, to be expended as provided in s. 259.02. The bond resolution adopted by the governing board of the Division of Bond Finance and approved by the Legislature may provide for additional provisions that govern the disbursement of the bond proceeds.
- (4) The Department of Environmental Protection shall distribute revenues from the Florida 2020 Trust Fund to state agencies, local governments, nonprofit or for-profit organizations, or individuals for the purposes of carrying out the provisions of s. 259.105. Such distributions shall be committed to the uses specified by s. 259.105 by the recipient within 90 days after the date on which the Department of Environmental Protection initiates the transfer.
- ensure that the proceeds from the sale of revenue bonds issued pursuant to s. 259.02 and payable from moneys transferred to the trust fund pursuant to s. 201.15(1)(a) and s. 201.155 shall be administered and expended in a manner that ensures that interest thereon will be excluded from gross income for federal income tax purposes, with the applicable provisions of the United States Internal Revenue Code and the regulations

adopted thereunder, to the extent necessary to preserve the 1 exclusion of interest on such revenue bonds from gross income 2 3 for federal income tax purposes. The Department of 4 Environmental Protection shall have the authority to 5 administer the use and disbursement of the proceeds of such 6 revenue bonds or to require that the use and disbursement of 7 such proceeds be administered in such a manner as shall be necessary to implement strategies to maximize any available 8 benefits under the applicable provisions of the United States 9 10 Internal Revenue Code or regulations promulgated thereunder, to the extent not inconsistent with the purposes identified in 11 12 s. 259.105. (6) Upon a determination by the Department of 13 14 Environmental Protection that proceeds being held in the trust 15 fund to support distributions outside the department are not likely to be disbursed and used in accordance with the 16 17 provisions of this section and s. 259.105, the department shall petition the Board of Trustees of the Internal 18 19 Improvement Trust Fund to allow for the immediate disbursement of such funds for the acquisition of projects approved for 20 purchase pursuant to the provisions of s. 259.105. 21 Section 2.
