Provides that such false personation during the commission of a felony which results in the death or personal injury of another human being is a felony of the first degree punishable by life. Provides penalties. Reclassifies and increases the penalties for the offense of use in or on a nongovernmentally owned vehicle or vessel of a flashing or rotating blue light by a person other than a specified law enforcement officer or special officer for a railroad or common carrier. Provides that such offense is a felony of the third degree. Provides for ranking of the offenses in the Criminal Punishment Code offense severity ranking chart. chart. 2.6
