On page 11, between lines 25 and 26,

insert:

Section 7. Paragraphs (d) and (e) of subsection (5) of section 320.08, Florida Statutes, are amended to read:

320.08 License taxes.--Except as otherwise provided herein, there are hereby levied and imposed annual license taxes for the operation of motor vehicles, mopeds, motorized bicycles as defined in s. 316.003(2), and mobile homes, as defined in s. 320.01, which shall be paid to and collected by the department or its agent upon the registration or renewal of registration of the following:

(5) SEMITRAILERS, FEES ACCORDING TO GROSS VEHICLE WEIGHT; SCHOOL BUSES; SPECIAL PURPOSE VEHICLES.--

(d) A wrecker, as defined in s. 320.01(40), which is used to tow a vessel as defined in s. 327.02(36), a disabled, abandoned, stolen-recovered, or impounded motor vehicle as defined in s. 320.01(38), or a replacement motor vehicle as

1 defined in s. 320.01(39): \$30 flat.

2 (e) A wrecker, as defined in s. 320.01(40), which is
3 used to tow any motor vehicle, regardless of whether or not
4 such motor vehicle is a disabled motor vehicle as defined in
5 s. 320.01(38), ~~or~~ a replacement motor vehicle as defined in s.
6 320.01(39), a vessel as defined in s. 327.02(36), or any other
7 cargo, as follows:

8 1. Gross vehicle weight of 10,000 pounds or more, but
9 less than 15,000 pounds: \$87 flat.

10 2. Gross vehicle weight of 15,000 pounds or more, but
11 less than 20,000 pounds: \$131 flat.

12 3. Gross vehicle weight of 20,000 pounds or more, but
13 less than 26,000 pounds: \$186 flat.

14 4. Gross vehicle weight of 26,000 pounds or more, but
15 less than 35,000 pounds: \$240 flat.

16 5. Gross vehicle weight of 35,000 pounds or more, but
17 less than 44,000 pounds: \$300 flat.

18 6. Gross vehicle weight of 44,000 pounds or more, but
19 less than 55,000 pounds: \$572 flat.

20 7. Gross vehicle weight of 55,000 pounds or more, but
21 less than 62,000 pounds: \$678 flat.

22 8. Gross vehicle weight of 62,000 pounds or more, but
23 less than 72,000 pounds: \$800 flat.

24 9. Gross vehicle weight of 72,000 pounds or more:
25 \$979 flat.
