Subsections (1) and (4) of section 430.502, 13 Florida Statutes, are amended to read: 430.502 Alzheimer's disease; memory disorder clinics 14 15 and day care and respite care programs. --(1) There is established: 16 17 A memory disorder clinic at each of the three 18 medical schools in this state; 19 (b) A memory disorder clinic at a major private 20 nonprofit research-oriented teaching hospital, and may fund a memory disorder clinic at any of the other affiliated teaching 21 hospitals; 22 23 (c) A memory disorder clinic at the Mayo Clinic in 24 Jacksonville; 25 (d) A memory disorder clinic at the West Florida 26 Regional Medical Center; 27 (e) The East Central Florida Memory Disorder Clinic at 28 the Joint Center for Advanced Therapeutics and Biomedical 29 Research of the Florida Institute of Technology and Holmes

- (f) A memory disorder clinic at the Orlando Regional Healthcare System, Inc.; $\frac{\mbox{\ and\ }}{\mbox{\ and\ }}$
- (g) A memory disorder center located in a public hospital that is operated by an independent special hospital taxing district that governs multiple hospitals and is located in a county with a population greater than $800,000 \; \mathrm{persons}$; and
- (h) A memory disorder clinic at St. Mary's Medical Center in Palm Beach County,

for the purpose of conducting research and training in a diagnostic and therapeutic setting for persons suffering from Alzheimer's disease and related memory disorders. However, memory disorder clinics funded as of June 30, 1995, shall not receive decreased funding due solely to subsequent additions of memory disorder clinics in this subsection.

(4) Pursuant to the provisions of s. 287.057, the Department of Elderly Affairs may shall contract for the provision of three specialized model day care programs in conjunction with the each memory disorder clinics clinic. The purpose of each model day care program must be to provide service delivery to persons suffering from Alzheimer's disease or a related memory disorder and training for health care and social service personnel in the care of persons having Alzheimer's disease or related memory disorders.

Section 2. This act shall take effect July 1 of the year in which enacted.

********** HOUSE SUMMARY Provides for establishment of a memory disorder clinic at St. Mary's Medical Center in Palm Beach County. Authorizes, rather than requires, the Department of Elderly Affairs to contract for the provision of specialized model day care programs in conjunction with memory disorder clinics.
