**I. FINAL ACTION STATUS:**

HB 3463 passed the House on April 23, 1998; in the Senate was substituted for SB 2384 and passed on May 1, 1998. Became law without Governor's signature on May 27, 1998. Chapter Law 98-238.

This legislation re-creates the Mobile Home and Recreational Vehicle Protection Trust Fund without modification. The Mobile Home and Recreational Vehicle Protection Trust Fund is administered by Department of Highway Safety and Motor Vehicles.
